- Candidates are required to apply for the post through online mode only. The on line
  application submitted if found to be incomplete in any respect is liable for rejection
  and no correspondence in this regard will be entertained.
- Candidates should not send the Detailed Application Form (DAF), copies of the certificate/documents or the originals to the Odisha Staff Selection Commission.
- The candidates should upload the documents as listed at clause 5 of this
  advertisement while applying online. They have to produce the originals of the
  same and a set of self attested Photo Copy of the uploaded certificates/documents
  at the time of certificate verification on the date of Viva-voce-cum-Psychological
  Test.
- Women & Person with Disabilities are not eligible to apply for the post.
- The candidate applying for the post must go through this detailed advertisement and ensure that he fulfils all the eligibility criteria prescribed for the post as laid down in this Detail Advertisement.
- The candidates applying for the post must have within 21 to 25 years of age as on 01.01.2017 with usual relaxation of upper age limit in case of SC/ST/SEBC candidates. The Ex-Serviceman candidates are eligible for age relaxation to the extent of years of service rendered in Defence Forces of Govt. of India.
- To be eligible to apply for the post, the candidate must have passed Bachelor in Veterinary Science (B.V. Sc.) from a recognised University. In case of nonavailability of candidates of required qualification, candidates having Bachelor of Science with Honours in Zoology from a recognized University shall be considered. As such candidates having Bachelor in Veterinary Science or Bachelor in Science with Zoology Honours shall be eligible to apply for the post.
- The appointment will be initially on contractual basis carrying a consolidated pay of Rs.9300/- + Grade Pay Rs.4200/- in the Scale of pay of Rs.9300/- to 34,800/- & Grade Pay Rs.4200/- and appointment will be guided by the Odisha Group-B Posts (Contractual Appointment) Rules, 2013 as per G.A. Department Notification No. 1147/Gen. dated 17.01.2014.
- Admission of a candidate for the Preliminary Exam./Physical Test/Main Written
   Exam & Viva-cum-Psychological Test shall be provisional and would be on the
   basis of the information furnished by him/her in the on-line application form.

Online Applications are invited by using website 'www.ossc.gov.in' for 6 (Six) posts of S.I. of Police Detective Dog Squad (K-9 Squad) under C.I.D. Crime Branch, D.G. & I.G. of Police in Home Department, Odisha. The posts will be initially on contractual basis as per Odisha Group-B posts (Contractual Appointment) Rules, 2013 in the Pay Band-2 i.e. Rs.9,300/-34,800/- with Grade Pay Rs.4200/- (Pre-revised) to be modified by the Govt. from time to time. 1. How to apply:

The applicants have to go through this detailed guidelines before filling up the online application.

- 1. (a) Aspirants have to apply online using the website of the Commission www.ossc.gov.in. The applicants other than the category of S.C. & S.T. are required to deposit examination fee of Rs.100/- either through online or offline mode using the Treasury Portal or by the conventional mode in the Head of Account- "0051-PSC-104-UPSC/SSC-Examination Fees-0047-Fees collected for conducting examinations-02041-Examiantion Fees" as detailed in the clause-4 of this advertisement before proceeding to fill in the online application for the post. By clicking on the tab 'online application' in the home page of the website, different advertisements for online application along with different useful details will be displayed on the computer screen. The instructions provided in this Advertisement are required to be read carefully before proceeding to complete the application process.

# (A) For Registration

All the Candidates first need to complete the Registration process before filling the Application Form.

For Registration the candidate needs to click the link "For Registration" present in the Form Link section.

On clicking the link mentioned, he/she will be redirected to the Registration Form, where few basic Details will be required like:-

All the above fields need to be filled in mandatorily by the candidate.

<u>Caution:</u> The candidate must submit the correct data in this section as the subsequent section will be automatically populated with the data filled in this section. No change in the section will be allowed after the candidates submit the 'I Agree' box.

Once the above details are filled in by the candidate and on clicking the 'I agree Box', I CAPTCHA image will be shown to the candidate which he/she needs to enter correctly in the field given below and then need to check the box "I Agree" for declaration and submit the registration form.

On Submitting the registration form a unique **Application Sequence No.** will be generated and will be shown to the candidate.

Application Sequence No. generated will act as the user id for the candidate.

Email and SMS will be sent to the candidates through his registered **email id** and **mobile no** intimating the 'User id' and 'password'.

#### Note:

The details submitted by the candidate for 10th Standard Roll Number (As Mentioned in the Certificate), 10th Standard Board, 10th Standard Year Of Passing & 10th Standard Passed Exam Type (Annual or Supplementary), Category, Sub-caste (SC/ST/SEBC only) need to be furnished correctly.

Furnishing of any wrong information may lead to rejection of the application and any request in this regard for correction of the same will not be entertained.

User registration is only required once during applying for a specific post/advertisement.

After successful submission of the registration form "Go to Application Form" & 'Logout' button will be visible on the top right hand corner of the window.

Candidate can click the "Logout" button if he/she wishes to exit the current session.


Candidate can also click on the "Go to Application Form" to continue with the filling of the application form.

#### (B) For registered user login

In order to fill in the Application form candidate needs to **click the link** present under "For registered user login" present in the Form Link section.

The same will redirect the candidate to the login page of the Application Form. The candidate needs to login using the 'user id' and 'password' he/she received after registration though e-mail as well as sms in the registered mobile no. & e-mail id.

Once the candidate successfully logged in to the application form he/she will be getting 4 tabs as follows:



- 1. Personal Details
- 2. Additional Details
- 3. Qualification details
- 4. Document Upload & Payment details

All the details required in the above 4 tabs need to be furnished correctly by the candidate. The details submitted by the candidate during submission of the registration form will be automatically populated in the respective fields of the application form.

The candidate have the option of filling the application form in more than 1 session but before logging out he/she needs to ensure that all the data filled by him/her has been saved by clicking "Save & Continue button" present in the end of the each tab.

Candidate can **preview** the application by clicking the "**Preview Application**" button present in the end of "**Document Upload & Payment details**" tab as and when required.

All candidates mandatorily need to upload the scanned image of his/her recent passport size photograph and scanned image of his/her full signature in the on line application form which must be within max 80 kb (The Format supported is JPEG, JPG). With addition to the above requirement all the candidates need to upload their 10<sup>th</sup> Standard mark sheet & certificate containing the 10th Standard Roll Number given in the registration form, +2 Science Pass Certificate& Mark Sheet and the Graduation in B.V.Sc. / B.Sc. in Zoology Hons. Certificate & Mark sheet (File size max 300kb each, format supported pdf) in Document Upload & Payment details section.

Candidate Claiming Category as SC, ST and SEBC needs to upload cast certificate (File size max 300kb, format supported pdf) in Document Upload & Payment details section.

Candidates Claiming "Ex-Serviceman" for age relaxation need to upload Ex-Serviceman proofs like **Discharge Certificate/I card/NOC (any 1 document)** in Document Upload & Payment details section (File size max 300kb, format supported pdf).

Candidates Claiming weightage marks from NCC certificate (A/B/C any one) needs to upload same (File size max 300kb each, format supported pdf) in Document Upload & Payment details section.

Candidates other than SC/ST category who are paying the examination fees of Rs.100 though **Treasury Challan** need to upload the same (File size max 300kb, format supported-pdf) in document Upload & Payment details section.

The uploaded documents must be clearly identifiable /visible, otherwise the application is liable for rejection and no correspondence in this regard will be entertained. The candidates are also advised to fill up relevant details under different tabs, mentioning Category, Sub Caste (in case of SC/ST/SEBC candidates), special category, present address, permanent address, full marks, marks secured and percentage of mark in H.S.C (Excluding Extra Optional Marks), at +2 level (Excluding Extra Optional marks) and at Graduation level required for eligibility of the post. The candidates having graduation from Open Universities without prequalification at H.S.C and +2 Levels may mention the same at the relevant column. The filled in Application Form can be submitted by clicking on the 'submit button'. - 1. (c) The candidate has to take out two printed copies, one Applicant's copy and the other OSSC copy and preserved the same for future use. The candidates qualifying in the Main Written Examination shall have to submit the Original Certificates & documents as per clause-5 of this advertisement along with a set of self attested Photocopy of the same along with OSSC copy of the application form legibly signed by the applicant in the appropriate place in the declaration at the bottom of the OSSC copy of the Application Form at the time of certificate verification on the day of Viva-voce-cum-Psychological Test.
- 1. (d) The Applicant's copy contains the 'user ID' and 'pass word' printed on the bottom of the Application Form. The applicant has to keep it carefully for his future reference to access to the website to know the status of his application and also to down load the call letter from the Commission's website at different stages of the recruitment process to appear the Examination/Test.
- 1. (e) Applications received incomplete or received through any mode other than online mode are liable to be summarily rejected.
- 1. - 1. (g) The candidate shall be provisionally allowed for different stages of recruitment process basing on the information furnished in the online application form. If at any stage of recruitment process or thereafter, it is found that any information furnished by the candidate in his application is false/incorrect or the candidate has suppressed any relevant information or the candidate does not satisfy the eligibility criteria prescribed for the post

# 2. (a) Vacancy position & Scale of Pay:

- N.B:- (ii) The numbers of vacant posts to be filled up on the basis of this recruitment process are subject to change at any time at the discretion of the Commission/Requisitioning Authority which be duly notified in the Commission's website.
  - (iii) Only male candidates are eligible for the post S.I. of Police Detective Dog Squad (K-9 Squad)
  - (iv) Women & Persons with Disability are not eligible to apply for the posts.
  - (v) There is no vacancy for Ex-Serviceman & Sports Persons. However the Ex-Servicemen Personnel may avail age relaxation to apply for the post.
- (b) Scale of Pay & Condition of Service: The appointment will be initially on contractual basis carrying a consolidated pay comprising of initial pay + grade pay in the scale of pay of Rs. Rs9300/- to 34,800/- and G.P. of Rs.4200/- (Pre-revised) subject to revision by the Government from time to time and appointment will be guided by the Odisha Group-B Posts



(Contractual Appointment) Rules, 2013 as per G.A. Department Notification No. 1147/Gen. dated 17.01.2014 and the Condition of Service shall be guided by Odisha Detective Dog Squad Service(Method of Recruitment & Condition of Service) Rules-2015.. 3. ELIGIBILITY CRITERIA FOR THE POSTS.
3(a) Age:

A candidate must have attained the age of 21 years and must not be above the age of 25 years as on 01.01.2017. Further the upper age limit is relaxable by 5 years in case of SC, ST & SEBC candidates and by the total period of service rendered in Defence Service in case of Ex-Servicemen candidate. However, a candidate can avail only one type of relaxation in age as per rule. To be eligible, candidates not enjoying any age relaxation of upper age limit must not be born earlier than 2nd January 1992 and not later than 1st January 1996. The Ex-Servicemen personnel having more than six months to be discharged from the forces as on the date of submission of online application form are not eligible to apply for the post. However such candidates who are due to retire within six months from the date of submission of on line application are eligible to apply for the posts. But such candidates shall have to submit the discharge certificate on the date of certificate verification for considering their claims under Ex-Serviceman category. Border Security Force, Indian Coast Guard, CRPF and other Para Military Forces are not within the definition of Ex-Servicemen. The In Service Contractual Employees engaged by the Govt. or through manpower service provider agencies in the State Govt. Offices or the State Govt. of Odisha are not eligible to get any age relaxation for this Post/Service.

Date of Birth recorded in the High School Certificate such as Board of Secondary Education of Odisha, Cuttack/ Central Board of Secondary Education, New Delhi/ Indian Council of Secondary Education, New Delhi or equivalent certificate issued by any Govt. Regd. Board/ Council will only be acceptable to the Commission.

#### 3(b) Educational Qualification

To be eligible to apply for the post, the candidate must have passed Bachelor in Veterinary Science (B.V.Sc.) from a recognised University. In case of non-availability of candidates of required qualification, candidates having Bachelor of Science with Honours in Zoology from a recognized University shall be considered. As such candidates having Bachelor in Veterinary Science or Bachelor in Science with Zoology Honours shall be eligible to apply for the post.

#### 3(C). General Eligibility Criteria

A candidate in order to be eligible for the posts/appearing at the competitive examination must be

- (i) Nationality Must be a citizen of India
- (ii) Knowledge in Odia He shall be able to speak, read and write odia and must have passed
- (a) Middle School examination with Odia as a language subject; or
- (b) Matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
- (c) Passed in Odia as language subject in the final examination of Class-VII or above; or
- (d) Passed a test in Odia in Middle English School Standard conducted by the Board of Secondary Education, Odisha.
- (iii) Marital Status A candidate if married must not have more than one spouse living:



(iv) Physical Fitness – A candidate must be of good mental condition and bodily health and free from any physical defect likely to interfere with the discharge of his duties in the service. A candidate, who after such medical examination as the Government may prescribe, is not found to satisfy these requirements shall not be appointed to the service.

Physically handicapped persons and women candidates shall not be eligible to apply for the post. The candidates possessing the minimum physical standard as detailed at clause-6(ii) are eligible to apply for the post.

(v) Eligibility of Government Employees: Government servants, whether temporary or permanent, are eligible to appear in the examination provided they possess the requisite qualifications and are within the prescribed age limit. Such candidates should submit the NOC from the concerned appointing authority at the time of viva-voce-cum-psychological Test.

#### 4. Examination Fee:

The candidates other than SC and ST category are required to deposit examination fee of Rs.100/-. The fees can be deposited either through online or offline mode using the Treasury Portal or by the conventional mode of deposit in the Treasury.

- 4(1)\* In case of e-payment the applicant is required to log on to <a href="www.odishatreasury.gov.in">www.odishatreasury.gov.in</a> or access through the link available in the OSSC portal.
- \* She/ He will click on the option of e-Payment and choose the option

## Other Deposit'

- \* The details of the challan will be filled in by the applicant
- \* She/He will choose the option for making the payment either through online or over the Bank counter mode of payment. In either case on submission of valid information, a **Challan Reference ID** will be generated.
- 4(2)\* For online payment, the payment will be made through Net Banking of the designated banks or through Debit Card. On successful payment, an e-Challan will be generated from the Treasury portal.
- 4(3)\* For over the Bank counter mode of deposit, the applicant will choose any designated Bank provided in the Treasury Portal and then proceed to the Bank branch where Offline payment of Government receipt is accepted. (The list of Bank branches for making offline payment is available at the Treasury Portal).
- \* On receipt of the payment, the depositor copy of the Challan form will be handed over to the depositor by the Bank.
- \* The challan will be deposited under the "Head of Account-0051-PSC-104-UPSC/SSC-Examiantion Fees-0047-Fees collected for conducting examinations-02041-Examiantion Fees".
- \* The applicant will fill in the challan reference ID and date in the online application.
- 4(4) The candidate has also the option to deposit the fee through the conventional mode into the Treasury under the Head of Account- "0051-PSC-104-UPSC/SSC-Examiantion Fees-0047-Fees collected for conducting examinations-02041-Examiantion Fees". In this case the candidate has to mention the Treasury Challan No. and date in the online application and upload the scanned copy of the challan.
- \* Non indication of correct and valid treasury challan no., date, and name of the Treasury in the application form relating to examination fees deposited through off-line mode will liable for rejection of the application.



SC & ST candidates are exempted from paying examination fee. The candidates other than these categories have to upload the Treasury Challan/E-challan in Document Upload & Payment details section (File size max 300kb, format supported pdf)

5. <u>Detailed Application Form (DAF) (copy of the self attested documents as uploaded in the on line application Form) to be submitted at the time of Certificate verification on the date of Viva-voce-cum-Psychological Test.</u>

The candidates qualifying in the Main Written Examination shall be required to submit the following original documents and a set of self attested photo copy of the same as uploaded earlier at the time of filling up the on line Application Form along with OSSC copy of the Online Application legibly signed at appropriate place and ID proof such as Voter ID/PAN Card/ Aadhar/ Driving Licence issued by any Govt. Authority before verifying Officer for necessary verification.

- (a) Candidates other than the category of SC/ST shall enclose original e-challan receipt/original Treasury Challan. (Depositor's copy)
- (b) Candidates of SC/ST category shall enclose self attested photocopy of caste certificate for the purpose of employment, issued by the competent authority.
- (c) Candidates of SEBC category should enclose self attested photocopy of valid SEBC certificate issued by the competent authority **not before one year** from the date of the submission of Online Application Form for the post.
- (d) Self attested photocopy of HSC or equivalent pass certificate & mark sheet in support of declaration of age issued by the concerned Board/Council.
- (e) Self attested photocopy of +2 Science or equivalent Examination Pass certificate & mark sheet.
- (f) Self attested photo copy of pass certificate of Degree examination i.e., B.V. Sc./B.Sc. in Zoology Hons, and Mark sheet.
- (g) In case of Ex-Servicemen, an attested copy of identity card/Discharge Certificate and the documents indicating the period of service rendered in Defence Forces.
- (h) Candidates have to submit a certificate either of passing HSC examination with Odia as a compulsory subject, or in lieu thereof a certificate of passing a language test in Odia of M.E. standard/Class-VII issued by competent authority.
- (i) In case of candidates already in Govt. Service, no objection certificate from the employer.
- (j) Self attested copies of NCC certificate and Fire Engineering certificates in support of claiming weightage marks.
- (k) The In-service Contractual Employees must submit a certificate from the employer indicating there in the Appointment Order No and date, Date of Appointment, Period of service completed, Post held, Nature of post, Scheme under which appointed & "no objection" to appear the examination along with a copy of the Appointment Order. There is no age relaxation for in service contractual employees.
- (l) Self attested copy of any of the Identity Card such as Voter's I. Card/PAN Card/Pass Port/Adhaar Card/ D.L. etc issued by any Govt. Authorities, with candidates' photograph there in.

# 6. (i) Stage-I -Preliminary Test (qualifying only)

- (i) The Preliminary Examination shall consist of one paper of 100 marks of **one hour** duration.
- (ii) The question shall be of objective type with multiple choices to be answered in OMR sheet.
- (iii) The questions shall be set proportionately from general science, current events of National & International importance, history of India and Odisha, Fundamentals of English grammar. Candidates up to 12 times of the vacancies in order of merit category wise as per vacancies advertised shall be shortlisted in the Preliminary Examination to appear in the Physical Measurement, Physical Efficiency & Practical Canine Test.



# 6.(ii) <u>Stage-II- Physical Measurement, Physical Efficiency Test & Practical Canine Test</u> (qualifying)

#### (c) Practical Canine Test:

In the Practical Canine Test the candidate's familiarity with dog shall be tested. The candidates' interaction with the trained dog, i.e. how he is fondling and taming the dog shall be judged in the presence of expert Member. The duration of the test shall be from 5 minutes to 10 Minutes. The canine Practical Test shall be done along with the Physical Test. The Test is qualifying in nature. Those who fail in Test shall be disqualified.

- Note-1) Failure in any of the Physical Measurement/ Physical Efficiency Test/ Practical Canine Test shall lead to disqualification of the candidate and he will not be eligible to appear in further Test(s) of the recruitment examination. # Syllabus for the Main Written Examination: (Rule-11 of the Recruitment Rule)

## (a) Paper-I: General English

The aim of the paper is to test the candidate's ability to read and understand serious and discursive prose and express his ideas clearly and correctly in English. The pattern of questions should broadly include the following with graduation standard.

- (i) Comprehension of a given passage.
- (ii) Précis Writing.
- (iii)Usage and vocabulary.
- (iv) Short essay writing.
- (v) Question to test the knowledge of Grammar report writing, letter/application.

# (b) Paper-II- Odia Essay on Canine Management and Utility.

An Odia Essay on Canine management & Utility shall be required to be written Odia Scipt in the prescribed time of 1& ½ hours.

# (c) Paper-III -General knowledge about breeds of dogs, their disease, preventive, first-aid etc.)

The question shall test general awareness of the candidates of a variety of subjects covering various fields of knowledge including knowledge of canine world as expected from any science graduate required for the post. The question shall be required to be answered in English.

- (a) Paper-IV- General Knowledge: The paper on general knowledge shall include questions covering the following fields of knowledge:
  - (i) General Science and recent scientific/ Technological Development.
  - (ii) Current events of National and International importance.



(iii)History of India from ancient time and Indian National Movement/ Indian Polity and Economy/ Indian and World Geography.

(iv)Encyclopaedia of Dogs.:

The questions in this paper-III & paper-IV will be of objective type with multiple choices of answers to be answered in OMR sheet.

#### 6.(iv)- Stage-IV- Viva-voce-cum Psychological Test:

Candidates three times of the vacancies in order of Merit category wise basing on the sum total of marks secured in Paper-I, II, III & IV taken together shall be shortlisted for Viva-voce-cum- Psychological Test. The Maximum marks in the Test shall be 30 marks.

#### 6.(v) Assessment of weightage marks:

The weightage marks from NCC certificate and Academic career will be calculated in case of the candidates who have appeared the Viva-Voce Test after due verification of their educational qualification and other documents before the Viva-voce-cum-Psychological Test.
