 - Note: (I) No examination fee has been prescribed for Departmental Candidates of Chhattisgarh State Power Companies.
 - (II) Candidates are advised not to fill up the form through Mobile Phone and use Laptop/Desktop Computers having browser Google Chrome (version 50 to 64)/ Mozilla Firefox (version 48 to 58)/ internet explorer (version 10 to 11) only. Before starting registration the browsing history should be cleared.

11. OTHER INSTRUCTIONS :

On successful registration of on-line application, candidates are advised not to attempt for registration for the same post again since multiple registration numbers and passwords may create problem for candidates in future. In case of multiple registrations for the same post, the candidature is liable for cancellation/rejection without any notice/intimation to the candidate.

- (ii) Admit card for online computer based test (CBT), containing the details of the centre/venue /date/time/etc. for the examination will be sent to the candidates at their registered e-mail ID only. The candidates are required to take a print-out of their admit card. The candidate can also download their admit card from the CSPHCL website "www.cspc.co.in" using their user id and the password, once email/sms alerts to this effect is sent.
- (iii) Candidates are advised to clear their browsing history before starting registration. Candidates are also advised in their own interest to apply on-line much before the closing date as per schedule mentioned in para 1 of this Recruitment Notice and not to wait till the last date of depositing the fee to avoid the possibility of disconnection/inability/failure to log on the CSPHCL's website on account of heavy load on internet/website jam/disconnection.
- (iv) The decision of the CSPHCL about the mode of selection to the post and eligibility conditions shall be final and binding. No correspondence will be entertained in this regard.

12. ACTION AGAINST MISCONDUCT:

At any stage of recruitment, if a candidate is / has been found guilty of following, he / she shall be straightway debarred from process at any stage of this Recruitment process:

- (i) Using unfair means during the examination; or
- (ii) Impersonating or procuring impersonation by any person; or
- (iii) Misbehaving in the examination hall; or
- (iv) Resorting to any irregular means in connection with his/her candidature during selection process; or
- (v) Obtaining support for his/her candidature by any means, such candidate in addition to rendering himself/herself liable to criminal prosecution and may also be liable to be:
 - (a) Disqualified from the examination; and
 - (b) Debarred either permanently or for a specified period from any examination/ recruitment in CSPHCL.
 - (c) There shall be complete ban on possessing or using the electronics devices/gadgets. Possession and Use of electronic devices/gadgets such as Mobile Phone, Micro Phone or any other Associated Accessories, wrist watch, Calculator, Log Tables, pager, Digital Diary, Book/ Notes etc. are strictly prohibited in the Examination Hall. If any candidate is found in possession of any of these devices / documents his/her candidature is liable to be cancelled, the candidate shall be banned at least for 5 years for applying for any post in CSPHCL and also liable for appropriate legal / penal action under the law. CSHPCL will not be responsible for its safe custody / loss. Consumption of liquor is prohibited & so intoxicated candidates may not be allowed to appear in examination.

13. OTHER TERMS & CONDITIONS:

(i) In case of large number of candidates in a particular city, the centre opted by the candidates as first preference, may not be allotted and candidates will be asked to appear at 2nd/3rd preference or any other new city. In case of less number of candidates in a particular city, the examination centre in that particular city may be cancelled. The decision on allotment of centre by CSPHCL will be final. The interview will be held at Raipur.

- (ii) The selected candidates can be posted in any of the Chhattisgarh State Power company i.e. CSPDCL/ CSPTCL/ CSPGCL based on merit list, option given by them and subject to vacancy available.
- (iii) CSPHCL has no mechanism to check the certificates as the candidates are applying online. If, at any stage certificate of the candidate is found to be forged/fictitious/bogus, the candidature of such candidate will be cancelled and action will be taken according to the law. In case the candidate is ineligible, the application shall be rejected.
- (iv) Only those departmental candidates, if selected, shall be eligible to be issued appointment order who are certified by the HOD as not having any pending SCN / disciplinary proceeding or undergoing/contemplated or under punishment period.
- (v) Candidates serving in Govt. / Quasi Govt. / PSU are required to submit "NOC" from their employer at the time of document verification, failing which candidature of such candidate may be rejected.
- (vi) Traveling expenses for outstation candidates for appearing in the online Computer Based Test and Interview / Document Verification will be paid to SC/ST/OBC candidates only as per Power Companies rule.
- (vii) The reserve category candidates selected in merit availing relax standard shall be considered against vacancy of the respective category.
- (viii) CSPHCL reserves the right to increase/decrease vacancy and also to cancel the complete process of recruitment, if required.
- (ix) Selected candidates will have to produce Medical Fitness Certificate from Divisional Medical Board for AE (Civil)-Trainee, A.O. /A.M.-(F&A)-Trainee, Ad.O./A.M. (HR)-Trainee, Medical Officer, Welfare Officer-Trainee, Programmer-Trainee and District Medical Board for JE (Trainee) based on the criteria prescribed by the Chhattisgarh State Power Companies.
- (x) <u>Training</u>: Selected candidates (Except Medical Officer) will have to undergo on the job training and institutional training for a total period of 12 months. Evaluation of performance in the training period will be assessed through a written exam followed by assessment by MD. The minimum qualifying marks for UR/OBC category will be 40% and for SC/ST category will be 30% in internal written exam. On satisfactory completion of training the trainee may be considered for appointment as Assistant Engineer (Civil), Accounts Officer / Assistant Manager (F&A), Administrative Officer / Assistant Manager (HR), Welfare Officer, Programmer & Junior Engineer (Civil) on probation for a period of two years which may be extended as per Power Companies rules.
- (xi) <u>Bond Amount</u>: The selected candidates will be required to execute a bond of Rs. 3.00 lakh for the post of AE (Civil)-Trainee, A.O. /A.M.-(F&A)-Trainee, Ad.O./A.M. (HR)-Trainee, Medical Officer, Welfare Officer-Trainee, Programmer-Trainee and Rs. 1.75 lakh for the post of JE (Civil)-Trainee, to serve the Power Companies for minimum period of four years (including period of training).

- (xii) In case of selection on the above said post, such selection shall be provisional subject to verification of character and antecedents of the candidate and verification of caste certificate and other documents submitted by the candidate and subject to his/her meeting the requisite medical standards.
- (xiii) The selected candidates will be governed by Chhattisgarh State Power Companies service rules and regulations as amended from time to time.
- (xiv) The selected candidates after regularization will be governed by the National Pension System (NPS).
- (xv) The candidate must bring print out of e-Admit Card at the Examination Centre along with original ID Proof. No candidate will be allowed entry without e-Admit Card and original ID proof i.e. Voter Identity Card, Driving License, PAN Card, Passport or Aadhar Card. The identity of the candidate will be matched from the ID proof. In addition, the Candidates are also advised to carry 02 recent coloured passport size photographs in the examination centre.
- (xvi) In case candidate is unable to get the admit card, he/she must contact personally at the facilitation centres to be opened 1 day before the online computer based test.
