GUIDELINES REGARDING PERSONS WITH DISABILITIES USING THE SERVICES OF SCRIBE

A scribe to take the test/examination on behalf of a Visually Impaired (VI) candidate and an Orthopedically Challenged (OC) candidate whose writing speed is affected by cerebral palsy. He/ she can use own scribe at own cost during the examination. In all such cases where a scribe is used, the following rules will apply:

- Please ensure you are eligible to use a scribe as per the Government of India rules governing the recruitment of Persons with Disabilities.
 - The candidate will have to arrange his/ her own scribe at his/ her own cost
- Both, the candidate as well as the scribe will have to give a suitable undertaking, in the prescribed format with passport size photograph of the scribe, confirming that the scribe fulfils all the stipulated eligibility criteria for a scribe as mentioned above. Further, in case it later transpires that he did not fulfill any of the laid-down eligibility criteria or suppressed material facts, the candidature of the applicant will stand cancelled, irrespective of the result of the test/ examination.
- Such candidate who uses a scribe shall be eligible for compensatory time of 20 minutes and or part thereof for every hour of the examination.
- Visually Impaired candidates under Blind/Low Vision using the services of scribe may skip the non-verbal questions in Test of Reasoning Ability and Graph/Table, if any, in Test of Quantitative Aptitude (wherever applicable). The candidates will be awarded marks for such Sections based on the overall average obtained in other Sections of the respective test.
