The District and Sessions Courts at Fatehabad would subsume and include Sub-Divisional Courts in the Sessions Division and experience of practice at Courts at Tohana would be valid experience as per the advertisement. Rajni Sharma had relied upon the experience certificate issued by the Bar Association, Tohana, District Fatehabad (Haryana) regarding 07 years experience of practice required for the post of Legal Officer, which is valid as per the minimum experience of 07 years as a Legal Practitioner or practicing Lawyer required under the advertisement.</li><li>2. Further, Rajni Sharma has a certificate issued by competent authority for the category Economically Weaker Section (EWS) and as such it is per se acceptable to claim reservation in EWS category</li></ol>	The experience certificate and category certificate of Rajni Sharma were found to be OK by domain expert.

There was only One seat reserved for PWD as per roster which was kept vacant as it was allocated, as per roster, for only Low Vision PWD candidates, whereas Amit Gupta's type of disability is Locomotor Disability.
