9. **National Education Alliance of Technologies (NEAT):** Monitoring the functions of theNational Educational Alliance for Technology (NEAT) aims to bring the besttechnological solutions in education pedagogy for enhancing the employability of theyouth. Technology solutions using Artificial Intelligence for customized, personalized,adaptive learning or e-content in niche areas having highly employable skill developmentare identified by a Committee of experts and showcased on the portal.
10. **SWAYAM :**The '**Study Webs of Active Learning for Young Aspiring Minds**'; (SWAYAM) is aprogramme initiated by Government of India and designed to achieve the three cardinalprinciples of Education Policy viz., access, equity and quality. The objective of thiseffort is to take the best teaching learning resources to all, including the mostdisadvantaged. This is done through an indigenously developed IT platform thatfacilitates hosting of all the courses, taught in classrooms from 9<sup>th</sup> standard till Post-Graduation to be accessed by anyone, anywhere at any time.
11. **SWAYAM Prabha:** The SWAYAM Prabha has been conceived as the project for telecasting high qualityeducational programs through 34 DTH channels on 24x7 basis to reach out tostudent/learners of India in a most cost effective manner using two GSAT-15transponders. It aims to support those students who do not have good learning optionslike lack of teacher or internet etc. 12 channels – One Channel One Class, are meant for Schools and 22 channels are earmarked for Higher Education.

It covers diverse disciplines such as arts, science, commerce, performing arts, social sciences and humanities, engineering, technology, law, medicine, agriculture, etc. Some of the channels also provide live interactions.
