 - i. Based on representations received, a wider meaning of relevant experience in the IT field is being taken, since in diploma or higher courses, the individual is expected to be well experienced with advanced subjects of computer science and IT fields like operating systems, databases, languages used in software development, computer algorithms, data structures, computer graphics, artificial intelligence, computer architecture, etc., in addition to the probable IT lab experience.
 - b. The teaching / lab instructor experience in school (upto +2 level) cannot be considered as relevant experience in the IT field since the curriculum taught in school is of very basic nature and does not qualify for relevant experience in the IT field.
 - c. The teaching experience in institutes (except govt. ITIs), coaching centers, etc. cannot be considered as relevant experience in the IT field since the subjects taught and the level of teaching involved is not enough to be considered as relevant experience in the IT field.
2. Comments regarding partial relevant experience: Earlier relevant experience was considered even if partial or minor responsibilities included relevant experience. However, on review and based on the representations received, if the relevant experience was partial or major responsibilities were not relevant for the experience required, the candidate's experience has been rejected.
3. It may be noted that IT and electronics fields are completely different. Experience in the Electronics field cannot be considered as relevant experience in the IT field.
