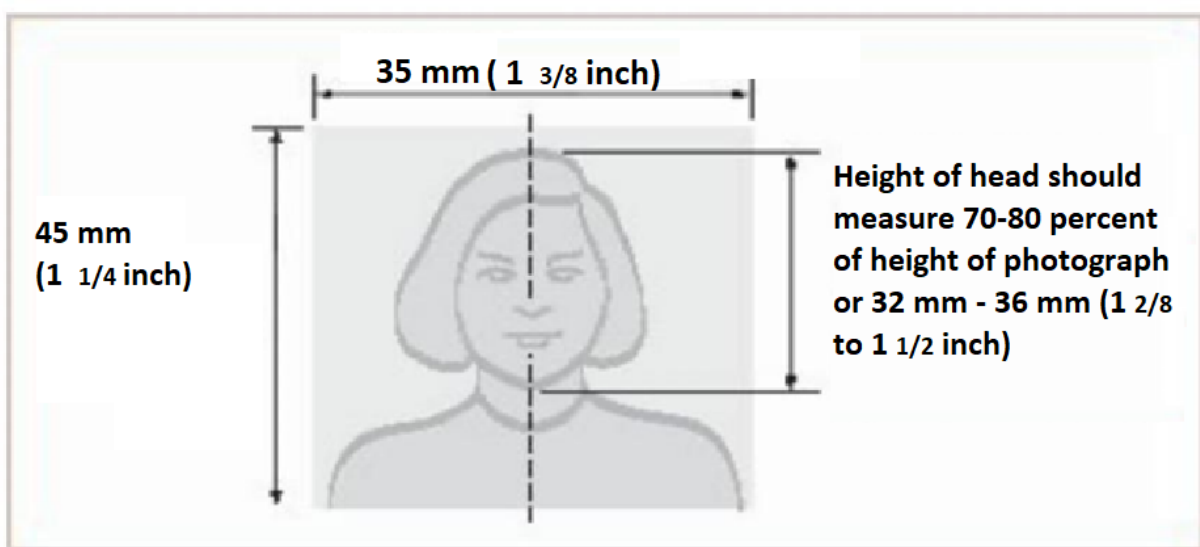


## Guidelines to Upload & Capture Photograph and Signature

Before applying online, a candidate will be required to have a scanned (digital) image of his/her photograph & signature as per the specifications given below. Your online application will not be registered unless you upload your photograph & signature as specified.

### A. PHOTOGRAPH

Processes for photo upload:



The candidate shall be required to capture and upload **TWO photographs**.

1. A **REAL TIME PHOTOGRAPH** taken by the webcam/in-built camera of the computer system while filling the online application form:
  - a. Stand/sit against a **white background** (Avoid distracting backgrounds).
  - b. There should be bright light falling on your face but not on the webcam.
  - c. The image **must not include other objects or additional people**. Ensure that you are only one person in picture.
  - d. The image must contain the full face, ears, neck, and shoulders of the entrant in frontal view with a neutral, non-smiling expression and with eyes open and directed at the camera.
  - e. The image must not contain any parts of the body below the entrant's shoulders.
  - f. Click on "Click here to Capture" button in the application form.
2. Upload a **RECENT PHOTOGRAPH** which can be prepared in following way:

**DO NOT UPLOAD MORE THAN 1 MONTH OLD PRE-MADE PHOTOGRAPH OF YOURS.**



- Photo has been taken against a white background without a border and clearly shows your face, eyes and both ears.
- Photograph is in colour.
- The image must not include other objects or additional people. Ensure that you are only one person in picture.
- The image must contain the full face, ears, neck, and shoulders of the entrant in frontal view with a neutral, non-smiling expression and with eyes open and directed at the camera.
- Head coverings, Turban, hair, head-dress, or facial ornaments should not obscure the face.
- The image must not contain any parts of the body below the entrant's shoulders.
- The size of image should be not less than 80KB and maximum of 200KB. Size of the image can be checked by right click on the image and then go to “Properties” link. (Maintain aspect ratio, i.e., height and width ratio to avoid distortion of image).
- The photograph is of standard passport size (45mm X 35mm, height X width).
- The photograph is recent (within 1 month of online application).
- Please note your photograph should be properly cropped / clear and should not be hazy or illegible.
- In case of poor-quality images, not properly cropped or swapping of photograph file, the application is liable to be rejected.
- Save the scanned images as .jpg/.jpeg as “Photograph.jpg” or “Photograph.jpeg.
- Image is in .jpg/.jpeg format.
- Digital enhancement or other alterations or retouching are not permitted.
- Make sure your face takes up at least 70-80% of the frame.

#### How to resize your photograph to 276 x 354 pixels

- Open your photograph with MS Paint.
- Select the resize option.
- Resize window will open by the system automatically when resize option is selected.
- Click on the pixels option.
- Click on maintain aspect ratio to un-check this option.
- Now Set the horizontal value to 276 and vertical value to 354 or set the scanner to 200 dpi then press ok.
- Save your photograph as .jpeg file.

#### B. SIGNATURE

Processes for Signature upload:




	
<b>Incorrect Signature</b>	<b>Correct Signature</b>

- Draw a box of size 2.5 cm (height) x 6.0 cm (width). Use a black or dark blue ink pen to sign within this box.
- Click the signature within the box in bright light conditions using any digital device. Avoid using flash.
- Check the shadow of your hands/camera/smartphone etc. does not fall on the sheet.
- The scanned image should be saved in .jpeg format.
- If the Candidate's signature on Admit card, at the time of the examination, does not match the signature on the Attendance Sheet, the candidate will be disqualified.
- The signature must be signed only by the candidate and not by any other person.

**Editing digital image of the signature:**

- a. Transfer the digital image to a computer/laptop.
- b. If required, use auto-correct feature of image editing software so that the signature is clear against a white background.
- c. Crop the image such that borders of box are reached.
- d. Resize the image to 50 – 200 KB (maintain aspect ratio, i.e., height and width ratio to avoid distortion of image)
